No. Whereas in order to develop Dhariwal town and its surroundings in an orderly manner, and to prepare Master Plan under "The Punjab Regional and Town Planning and Development Act, 1995, Local Planning Area, Dhariwal was declared vide Notification No. 12/3/2010-4HG1/1737, dated 9/6/10 under section 56 (1) of the said act.


Whereas the Chief Town Planner, Punjab, was declared as Planning Agency for aforesaid Local Planning Area under section 57 of "The Punjab Regional and Town Planning and Development act 1995" vide notification No. 12/3/2010-4HG1/1743, dated 9/6/10.

Whereas Planning Agency prepared the draft Master Plan for Local Planning Area, Dhariwal and published the same under Section 70 (3) of "The Punjab Regional and Town Planning and Development Act, 1995", for inviting objection on 23-5-2014 from the general public.

Whereas no objection was received from the general public. Thereafter, the Government in consultation with The Punjab Regional and Town Planning and Development Board's 30th meeting held on 09.12.2015 has approved the Master Plan, Dhariwal.

Now, therefore in exercise of powers conferred under Section 70 (5) of "The Punjab Regional and Town Planning and Development Act, 1995", the final Master Plan, Dhariwal comprising written report and drawings of Existing Landuse Plan-2010 Drawing No. D.T.P (G) 21/2011 dated 03/11/2011, Proposed Landuse Plan (2010-2031) Drawing No. D.T.P (G) 16/2013 dated 18/12/2013 & 12/01/2016 are hereby notified.
